Legal Change of Form and File for 1099 Reporting
Changes in Record A according to Internal Revenue Bulletin 2007-30
Three fields were deleted from the Payer 'A' Record and are no longer required. The deleted fields are Original File Indicator, position 48, Replacement File Indicator, position 49 and Correction File Indicator, position 50, Positions 48-50 are now blank.

The only change in the form is the year, which shows now 2007.
